✓ Low Severity Issues

1. Out of gas

Issue:

- The function `excludeMultipleAccountsFromFees()` uses the loop to exclude multiple accounts from fees. Function will be aborted with `OUT_OF_GAS` exception if there will be a long addresses list.

Recommendation:

Be careful about accounts array length.

Issue:

- The function `multisend()` uses the loop to multitransfer. Function will be aborted with `OUT_OF_GAS` exception if there will be a long addresses list.

Recommendation:

Be careful about array length.

2. Array length equity

Issue:

- The function `multisend()` do not compare `dests` array length with `values` array length.
- Also function do not checks `msg.sender` balance to fit values sum.

Recommendation:

Add needed comparisons to avoid wrong function working.

Owner privileges (In the period when the owner is not renounced)

- Owner can enable/disable swapAndLiquify.
- Owner can change Uniswap router.
- Owner can exclude from the fees.
- Owner can change fees and fee wallets.
- Owner can exclude and include addresses in automatedMarketMakerPairs array.
- Owner can withdraw contract ERC20 tokens and BNBs.
- Owner can change minimum tokens before swap.
- Owner can change transaction amount.

Conclusion

Smart contracts contain low severity issues! Liquidity pair contract's security is not checked due to out of scope. The further transfers and operations with the funds raise are not related to this particular contract.

Liquidity locking details NOT provided by the team.
